Housing Authority of the Cherokee Nation | Annexation 2022-04

- The applicant representing the owner, Tony Popp with TriArch, is requesting a review of the annexation proposal for the parcel owned solely by the Housing Authority of the Cherokee Nation that is a part of the Northwest quarter of the Southwest quarter (NW4 SW4) and the West half of the Northeast quarter of the Southwest quarter (W2 NE4 SW4) of Section 26, Township 22 North, Range 13 East of the Indian Base and Meridian, Tulsa County, State of Oklahoma, according to the United States Government survey thereof, being more particularly described as follows, to-wit;

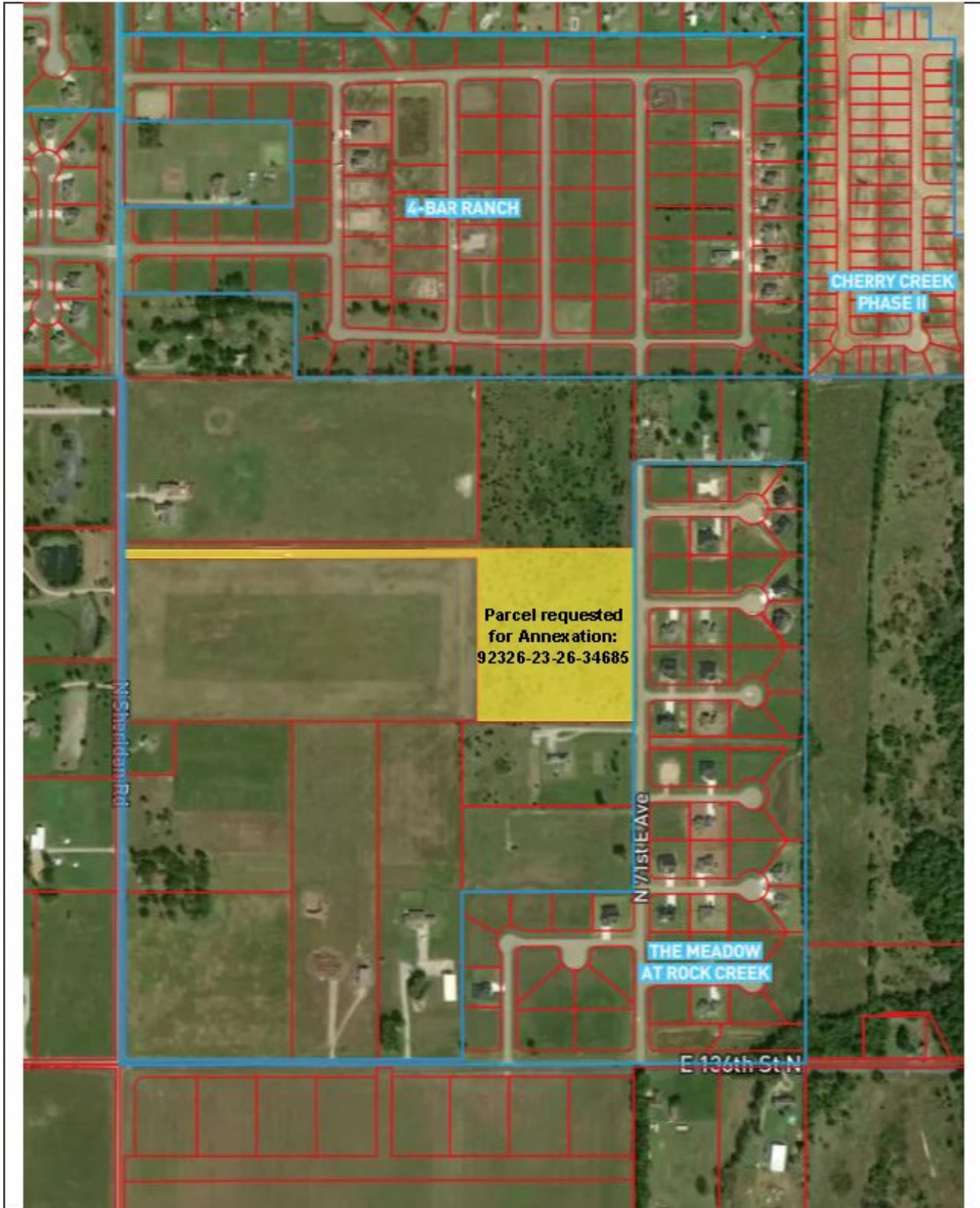
COMMENCING AT THE NORTHWEST CORNER OF THE SW4 OF SAID SECTION 26; THENCE SOUTH 00°04'10" WEST ALONG THE WEST LINE OF THE SW4, A DISTANCE OF 660.71 FEET TO THE POINT OF BEGINNING; THENCE SOUTH 89°59'36" EAST A DISTANCE OF 1988.13 FEET TO A POINT ON THE EAST LINE OF THE W2 NE4 SW4; THENCE SOUTH 00°04'02" WEST ALONG THE EAST LINE A DISTANCE OF 660.87 FEET TO THE SOUTHEAST CORNER OF SAID W2 NE4 SW4; THENCE NORTH 89°59'1" WEST ALONG THE SOUTH LINE OF SAID W2 NE4 SW4 A DISTANCE OF 601.15 FEET TO A POINT THAT IS 1387.0 FEET EAST OF THE SOUTHWEST CORNER OF THE NW4 SW4; THENCE NORTH 00°04'10" EAST A DISTANCE OF 630.82 FEET; THENCE NORTH 89°59'36" WEST A DISTANCE OF 1387.0 FEET TO A POINT ON THE WEST LINE OF SAID SW4; THENCE NORTH 00°04'10" EAST ALONG SAID WEST LINE A DISTANCE OF 30 FEET **TO THE POINT OF BEGINNING.**
